## By-Law 2020-113

Being a By-Law to Amend the Municipality of Brockton Comprehensive Zoning By-Law 2013-26, as Amended.

Whereas The Council for The Corporation of the Municipality of Brockton deems it expedient to amend By-Law 2013-26, as amended being the Comprehensive Zoning By-Law for the Municipality of Brockton;

**Now Therefore** the Council of the Corporation of the Municipality of Brockton pursuant to Section 34 of the *Planning Act, R.S.O. 1990* enacts as follows;

- 1.0 That Schedule 'A' to By-Law No. 2013-26, as amended, is hereby further amended by changing the zoning that applies to Concession 1 NDR South Part Lot 39, & Concession 1 NDR Part Lot 39 Geographic Township of Greenock, Municipality of Brockton from General Agriculture (A1) and Environmental Protection (EP) to:
  - a) General Agriculture Special (A1-112);
  - b) General Agriculture Special (A1-113); and
  - c) Environmental Protection (EP).
- 2.0 That By-law No. 2013-26, as amended, is hereby further amended by adding the following subsection to Section 6.3 thereof:
  - a) Notwithstanding their 'A1' Zoning designation, those lands delineated as 'A1-112' on Schedule 'A' to this By-law shall be used in accordance with the 'A1' Zone provisions contained in this By-law, excepting however, that:
    - i) The minimum lot area shall be no less than 4.58 ha
  - b) Notwithstanding their 'A1' Zoning designation, those lands delineated as 'A1-113' on Schedule 'A' to this By-law shall be used in accordance with the 'A1' Zone provisions contained in this By-law, excepting however, that:
    - i) The minimum lot area shall be no less than 15.49 ha
    - ii) The minimum lot frontage shall be no less than 98.75 m
- 3.0 That this By-law shall come into force and effect on the final passing thereof by the Council of the Municipality of Brockton, subject to compliance with the provisions of the *Planning Act, R.S.O. 1990*.
- 4.0 This By-Law may be cited as the "Zoning Amendment By-Law Milos Z-2020-053".


