Occupant information is used to identify municipal and school board electors; owners and tenants are potential electors in every municipality in which they are an owner or tenant of property. This information is also used to identify potential jurors and determine the population for each municipality in Ontario. Municipalities and school boards rely on this information to help determine where to expand municipal services or locate new facilities such as community centres and schools.

**This Request for Occupant Information is normally sent to all households where there has been a change of ownership or tenancy, or to households for which MPAC may not have complete nor accurate information. It is also used to advise MPAC of changes or corrections to personal information related to any residential, commercial or industrial property, including vacant land, on which the person is an owner or tenant.**

**Instructions:** Use one form for each property for which you are an owner or tenant. If this form is for your 'primary residence', please include children's names. Do not list children if this form is for another property, such as a cottage. Please provide all requested information, including gender, birth dates and citizenship, occupancy and residency status.

 This information will be used to determine the number of trustees each school board is permitted to field during future elections. If you want to be a supporter of:  
 English-Public Anyone may support English-Public  
 English-Separate **You** must be Roman Catholic  
 French-Public **You** must have French language education rights  
 French-Separate **You** must be Roman Catholic and have French-language education rights

**French-language Education Rights**  
 You have French-language education rights if you are a Canadian Citizen and can answer 'yes' to any one of the following:  
 1. Is French the language you first learned and still understand?  
 2. Did you receive your elementary school instruction in Canada in French? (does **not** include French immersion nor French as a second language)  
 3. Have any of your children received, or are they now receiving, elementary or secondary school instruction in Canada in French? (does **not** include French immersion nor French as a second language)
