## By-Law 2020-051

Being a By-Law to Amend the Municipality of Brockton Comprehensive Zoning By-Law 2013-26, as Amended.

Whereas The Council for The Corporation of the Municipality of Brockton deems it expedient to amend By-Law 2013-26, as amended being the Comprehensive Zoning By-Law for the Municipality of Brockton;

**Now Therefore** the Council of the Corporation of the Municipality of Brockton pursuant to Section 34 of the *Planning Act, R.S.O. 1990* enacts as follows;

- 1.0 That Schedule 'A' to By-Law No. 2013-26, as amended, is hereby further amended by changing the zoning symbol on CON A PT LOT 29 PL 63 PT LOT;59 RP3R 5464 PART 1, Geographic Township of Greenock, Municipality of Brockton to A1-110 General Agriculture Special, A1-109 General Agriculture Special, HR- Hamlet Residential and EP-Environmental Protection as shown on Schedule 'A' attached hereto and forming a part of this By-law.
- 2.0 That By-law No. 2013-26, as amended, is hereby further amended by adding the following to Section 6.3:

The lands zoned as 'A1-109' on Schedule 'A' to this By-law shall be used in compliance with the 'A1' zone provisions contained in this By-law, excepting however:

- i. The frontage shall be no less than +/- 19 m.
- ii. The number of nutrient units shall be no more than 1.25 per hectare.

The lands zoned as 'A1-110' on Schedule 'A' to this By-law shall be used in compliance with the 'A1' zone provisions contained in this By-law, excepting however:

- i. A 'Dwelling, Accessory Detached' shall be prohibited.
- ii. That the lot area shall be no less than +/- 29 ha.
- 3.0 That this By-law shall come into force and effect on the final passing thereof by the Council of the Municipality of Brockton, subject to compliance with the provisions of the *Planning Act, R.S.O. 1990*.

4.0 This By-Law may be cited as the "Zoning Amendment By-Law - Wells Z-2020-028".


